<b>HMCCQ member requesting SIVS registration</b> <b>Part A</b> on the form only	<ol style="list-style-type: none"> <li>1. Print <b>3 copies</b> of the certificate.</li> <li>2. On each copy fill in <u>Part A only</u> (photocopies are not acceptable)</li> <li>3. Take the forms + your membership card + the machine + any documentary evidence (e.g. proof of machine age) to the HMCCQ Area Inspection Officer for verification.</li> </ol>
<b>HMCCQ Area Inspection Officer</b> <b>Part B</b> on the form only	<ol style="list-style-type: none"> <li>1 Check the details on all 3 original copies of the form match.</li> <li>2 Inspect the machine and confirm the details are correct.</li> <li>3 Check current membership.</li> <li>4 Witness (watch) the applicant sign and date all 3 copies of the form</li> <li>5 Print your full name, sign and date all 3 copies of the form in <u>Part B only</u>.</li> <li>6 Keep one copy of the form for your records for 12 months.</li> </ol>
